

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient in consideration of the acceptance of this event and of the opportunity to have the dog judges and to win prizes, ribbons, or trophies. I (we) agree to hold the AKC, the event-giving club, its members, directors, governors, officers agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which any be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrances thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claims for loss, injury, or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries. Including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence or my (our) participation in this event, however such, injuries, death or property damage may be caused and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THIS ENTRY, EXHIBITION OR ATTENDANCE AT THIS EVENT BETWEEN THE AKC AND/OR THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL AKC APPLICABLE BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**

INSTRUCTIONS

2. (Dog Show Class) Consult the classification in this premium list, if the dog show class in which you are entering is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, height.
3. A dog must be entered in the name of the person who actually owned it at the time entries for the show closed. If a registered dog has been acquired by a new owner it must be entered in the name of the new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating the dog is recorded in his name. State on the entry form whether transfer application has been mailed to the A.K.C. (For complete rule refer to Chapter 14, Section 3)
