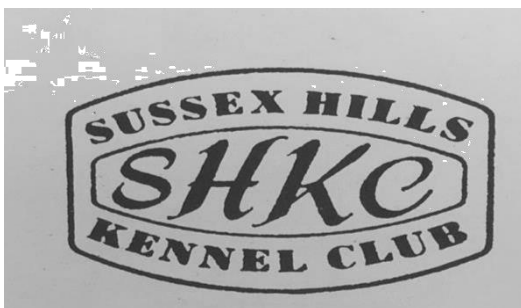

Day of test entries are \$30.00 for each entry and will close 30 minutes prior to roll call at the Field Secretary's table. **Day of Test entries accepted as space allow.** A stand-by list will be created and these dogs will be allowed to run if time permits. Entries will be acknowledged by email if a legible email address is provided on the entry form.

Conditions of Entry

Dogs must have an AKC registration number and be at least one year of age on the day of the trial. Dogs may run once per test. All entries must be accompanied with a check to be valid. Entries received by phone, text or email will not be accepted. Incomplete entries or forms without signatures will not be accepted.

FAST CAT events are open to all dogs, at least 12 months of age that are individually registered with AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid are eligible to participate.

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The inspection committee has the authority to disallow a dog's entry into a test and, in such instances; applicable entry fees will be refunded. At roll call, all dogs will be measured by a wicket to verify handicaps. Bitches in season, lame or unfit dogs will be excused with entry refunded.

WHAT IS A FAST CAT?

Coursing is an athletic activity that can tax a dog's physical strength.

Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The inspection committee has the authority to disallow a dog's entry into a test and, in such instances; applicable entry fees will be refunded. At roll call, all dogs will be measured by a wicket to verify handicaps. Bitches in season, lame and unfit dogs will be excused with entry refunded. **Please do not bring bitches in season to the test.**

FAST CAT is a timed straight 100 yard dash for dogs. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into the catch pen. The course is completely fenced and dogs run individually. Dogs are timed when they complete the 100 yard dash. The time is converted to Miles Per Hour (MPH)

Formula: $2045.545/\text{run time} = \text{MPH}$

Based on the dogs size at the withers, a handicap is applied and points are earned.

- 18" or greater = Handicap is 1.0
- 12" up to 18" = Handicap is 1.5
- Below 12" = Handicap is 2.0

MPH X HANDICAP = POINTS

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

BCAT = 150 POINTS

DCAT = 500 POINTS

FCAT = 1,000 POINTS

FCAT# - EACH ADDITIONAL 500 POINTS

TOP 20 BY BREED BY YEAR

TRIAL HOURS

Grounds will be available from 7:30AM. Roll call and Exhibitor briefing begins are 8:30AM for morning test. PM Roll call and briefing will begin 30 minutes after the completion of the morning test. CSCNJ/SHKC/SHKC will make every attempt to facilitate that all entrants will be accommodated with running their dogs in the trials, but it is also the responsibility of each entrant to make an effort to be ready when their dog is called to the line.

TRIAL TIMES

Morning trial starts at 9:00AM each day and until all runs are completed. CSCNJ/SHKC/SHKC will do its best to accommodate exhibitors. However, exhibitors must notify the Field Trial Secretary of possible conflicts and must work their dogs into the running order during the regular test schedule. No dog will be moved up. If you are not available when your dog is called, your dog will be skipped but not marked absent, the next dog will be called. You may request to enter your dog in the running order at any time after the dog has been skipped during the test.

ROLL CALL

Morning Roll Call – 8:30AM

Afternoon Roll Call – 30 minutes after the Conclusion of Morning Trial

PRIZES

CSCNJ/SHKC/SHKC will offer a light blue flat ribbon for a passing qualifying run.

CSCNJ/SHKC/SHKC will offer placement ribbons at each trial for:

- Fastest 1st-4th in under 12" class
- Fastest 1st-4th in 12" – under 18" class
- Fastest 1st-4th in 18" or greater class

CSCNJ/SHKC/SHKC will have a limited number of rosettes available for dogs earning titles.

TRIAL INFORMATION

- Please pick after your dog so we can continue to use this wonderful park. Any exhibitor caught not cleaning up after their dog will be asked to leave the trial grounds. NO REFUND will be given if this occurs. A \$5.00 fine will be assessed for any loose dog on the field not competing.
- Dogs should be warmed up before and cooled down after running.
- **ALL DOGS RUN AT THE OWNER'S SOLE RISK.**
- All entries must be 12 months of age or older on the day of the test.
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain or shine outdoor event. Plan accordingly. Please bring your own shade, chairs and water.
- An electronic timing system will be used. An electric continuous loop, plastic strip lure machine will be used.
- The show grounds are NOT completely fenced, the FAST CAT course will be fenced.
- On site bathroom facilities will be available.
- Dogs must be on leash or crated unless running.
- You are responsible for controlling your dog and children. Only one handler may be in the catch pen at a time.
- Each dog requires an individual entry. You may use one form to enter one dog for some or all events. Use the checkbox and indicate each event you wish to enter, \$25.00 per entry.
- The huntmaster is responsible for field safety and therefore he/she is in complete charge of ALL DOGS and HANDLERS on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Persons exhibiting conduct detrimental to the Sport of Pure Bred Dogs, AKC, CSCNJ/SHKC/SHKC, or any dog(s) or other person(s), will be asked to leave the trial site by the Field Committee, may face discipline by the Bench Committee and AKC. **Entry fees will not be refunded.**
- **NO ENTRY FEES WILL BE REFUNDED** if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, strikes or any other cause beyond the control of the clubs or the event-hosting club.
