



## **MEMBERSHIP REQUIREMENTS**

The Somerset Hills Kennel Club meets the third Monday of March, April, June, August and October at 7:00 P.M. We also have an Awards Banquet in December for members.

1. Should you be interested in joining the Club, the requirements for membership may be obtained only after you have attended a minimum of two regular meetings within the preceding six months and worked at two club functions such as the Point Show, Match, Public Education, Agility Trial, Handling Classes or other functions approved by the Board. At least one of the two shall be the Club's Point Show, Agility Trial or Match Show. Membership applications and sponsor forms can be obtained from the Memberships Chairperson or the Secretary.
2. The completed application form may be submitted to the Membership Chairperson or the Secretary. The following items must be included with the application:
  - a) A signed Code of Ethics;
  - b) Two completed Member Sponsor forms. The two sponsors must be from separate households and have been members of Somerset Hills Kennel Club for at least one year.
  - c) A check covering membership dues made payable to, "Somerset Hills Kennel Club." Dues are \$20.00 per person.
3. The application will be read at the next meeting following receipt. Applicant's names will be published in the notice for the first General Membership Meeting after the reading, at which time, and after considering the recommendation of the Board, the membership will vote on the application.

New members will receive a copy of the Constitution and By-laws and a Membership List. We look forward to seeing you at future club meetings.
